Comprising a long established fully fitted restaurant arranged over ground and first floor with additional dining at first floor level plus WC’s and storage. The ground floor is arranged as dining, bar area and fully fitted kitchen. We are not selling these premises as a going concern, but as fully fitted restaurant premises suitable for any cuisine. Arranged as 60 covers and trading under the current ownership for around 12 years. The premises are fully air conditioned (*not tested). There is a fold back shop front to the high street.
