The premises are within close proximity to the new Beaufort Park Development and the new residential schemes being built in the area. The premises are midway between Hendon Central underground station and Colindale underground station (Northern Line).

Description: Comprising a long established traditional restaurant premises which is suitable for either taking over and running in its existing form or re-fitting as a new style restaurant or a take-away only operation (the premises has space at the back for delivery scooters). The premises are currently arranged with 62 covers, bar area, WC's, fully fitted kitchen, store/cold-room and has gas central heating (not tested). Parking around this location in the evenings is unrestricted. The premises are highly visible to the traffic flows of the A41. The premises are offered for sale with all fixtures, fittings and equipment (not tested).
